Reports to Lori Whiting, Financial Aid, and BJ Addison, Woodville Elementary School Principal. This position will be for the Fall and Spring semesters.

Qualifications:

- Must have a completed Free Application for Federal Student Aid on file for 23-24 aid year.
- Must be registered for the current term and must meet satisfactory academic progress (SAP) standards.
- Applicants should be neat in appearance and possess the ability to work well with others.
- Applicants must be dependable, punctual, and be able to work well with others.
