

Updated for the period ending December 31, 2021:

NGTC - CARES ACT

The Coronavirus Aid, Relief and Economic Security (CARES) Act was signed into law (Pub. L. 116-136, 134 Stat. 281 (March 27, 2020) and established the Higher Education Emergency Relief Fund (HEERF) for colleges to distribute emergency financial aid grants to students and institutions of higher education. These funds are separate from those awarded under the [American Rescue Plan](#) and [Coronavirus Response and Relief Supplemental Appropriations Act \(CRRSAA\)](#).

Emergency Financial Aid for Students: Disbursement Plan

The U.S. Department of Education (“USDOE”) has allocated \$1,057,016.00 to North Georgia Technical College (“the college”) for these emergency financial aid grants to students. The college has signed and returned to the USDOE the Certification and Agreement and the assurance that the College intends to use no less than 50% of the funds allocated under Section 18804(a)(1) of the CARE Act for students. These funds are to be used to provide Emergency Financial Aid Grants to Students for expenses related to the disruption of campus operations due to the COVID-19 pandemic. Eligible expenses include food, housing, course materials, technology, health care, and child care. Students who meet basic eligibility criteria for federal financial aid (Title IV) funding were considered for the HEERF. Information from the Free Application for Federal Student Aid (FAFSA) were used to determine eligibility for Emergency Grant Funds.

Student Eligibility:

- Active enrollment on March 13, 2020 for a minimum of one (1) credit hour in a Title IV eligible program that leads to a certificate, diploma, or degree
- Have completed a FAFSA for the 2019-2020 aid year with all C codes on FAFSA cleared
- Have a FAFSA that does not have any outstanding verification requirements
- Have met all requirements for admission
- Have a Spring term Satisfactory Academic Progress (SAP) code status of good standing, warning or an approved Academic Plan

Student Not Eligible for Emergency Grant Funds

Student populations determined as not eligible for Emergency Grant Funds as defined by the U. S. Department of Education:

- Dual Enrolled High School Students
- Foreign students to include DACA students
- Transient students – these students may receive funds from home institution
- Students having defaulted on student loans, overpayments or have other loan restrictions.
- Students enrolled in Minimester A courses that ended prior to March 13, 2020

Proposed Process for Awarding and Disbursing Emergency Funds to Student

Based on the eligibility requirements above, the college initially identified 1,339 students who met eligibility requirements to receive Emergency Grant Funds. The college disbursed funds to those students determined to be eligible. There were 535 students enrolled in the spring who had unmet eligibility requirements to receive Emergency Grant funds. Funds were awarded by the Financial Aid Department and disbursed to student accounts. Each student account showed a credit balance. Since CARES Act funds cannot be used to cover tuition and fees, the award generated a refund. The Business Office disbursed the credit balance to BankMobile for release to the student.

The college subsequently determined that there were approximately 130 students enrolled in the spring term who may be eligible with the completion of the 2019-2020 FAFSA.

The College disbursed funds to two cohorts: Cohort 1 from the Spring term and Cohort 2 from the Summer term.

Identification of Cohort 1:

Cohort 1 consisted of those students who have already completed the Free Application for Federal Student Aid (FAFSA) for 2019-2020 and have met all eligibility requirements stated above. The college initially identified 1,339 students for Cohort 1 who were enrolled in a Title IV eligible program as having completed a 2019-2020 FAFSA with no outstanding documents.

The total funding amount allocated to Cohort 1 was \$712,792.74 resulting in an award of \$532.73 per student.

Identification of Cohort 2:

The college subsequently determined that students who were eligible for Emergency Grant Funds from the spring term and enrolled in the summer term continued to face impact from the COVID-19 virus. Cohort 2 consisted of students who were determined to be eligible for Emergency Grant Funds from the Spring term who continued credit enrollment in the Summer term. There were 815 students registered for a credit class in the summer term who were eligible to receive emergency grant funding in the spring term. These students continued to meet all eligibility requirements as stated above.

Students attending the Spring term who did not complete the 2019-2020 FAFSA prior to the disbursement to Cohort 1 were considered for Cohort 2 if they submitted a 2019-2020 FAFSA and met all eligibility requirements as stated above by June 1, 2020. Student Affairs contacted this group of students and offered assistance with filing a FAFSA application by the stated deadline.

The total funding amount allocated to the Cohort 2 during the Summer term to summer students who were enrolled in spring term was \$228,872.41.

The total funding amount allocated to spring students who did meet the eligibility requirements at the time of disbursement of Cohort 1, but later became eligible was \$115,350.85

Should any Emergency Grant funds remain following the distribution to Cohort 2, the college will disburse the balance of remaining funds to the eligible students identified in Cohort 1 and Cohort 2. Funds were disbursed prior to the completion of the Summer term. The College sent an email and text once the funds were disbursed to student accounts.

The total number of students who have received an emergency financial aid grant as of December 31, 2020, was 1,556.

CORONAVIRUS RESPONSE AND RELIEF SUPPLEMENTAL APPROPRIATIONS ACT 2021

The Coronavirus Response and Relief Supplemental Appropriations Act 2021 (CRRSAA) was signed into law (Pub. L. 116-260 (Dec. 27, 2020)) which provides additional funds for the Higher Education Emergency Relief Fund (HEERF) to assist public and private nonprofit colleges and universities in preparing for, preventing, and responding to the COVID-19 global pandemic. These funds are separate from those awarded under the [American Rescue Plan](#) and [Coronavirus Aid, Relief and Economic Security \(CARES\) Act](#).

Student Not Eligible for Emergency Grant Funds

Student populations determined as not eligible for Emergency Grant Funds as defined by the U. S. Department of Education:

- Dual Enrolled High School Students
- Joint Enrolled High School Students
- Transient students – these students may receive funds from home institution
- Adult Education (non-credit) Students

Proposed Process for Awarding and Disbursing Emergency Funds to Student

Based on the eligibility requirements above, the college initially identified 1,326 students who met eligibility requirements to receive Emergency Grant Funds. The college disbursed funds to those students determined to be eligible. There were 81 students enrolled in the spring who had unmet eligibility requirements to receive Emergency Grant funds. Funds were awarded by the Financial Aid Department and disbursed to student accounts. Each student account showed a credit balance. HEERF II Act funds can be used to cover tuition and fees balances, if the student gives prior authorization. The Business Office disbursed any credit balance to BankMobile for release to the student.

The college subsequently determined that there were approximately 141 students enrolled in the spring term who may be eligible with the completion of the 2020-2021 FAFSA.

The College disbursed funds to two cohorts: Cohort 1 from the Spring term and Cohort 2 from the Summer term.

Identification of Cohort 1:

Cohort 1 consisted of those students who have already completed the Free Application for Federal Student Aid (FAFSA) for 2020-2021 and have met all eligibility requirements stated above. The college initially identified 1,335 students for Cohort 1 who were enrolled in a Title IV eligible program as having completed a 2020-2021 FAFSA with no outstanding documents.

The total funding amount allocated to Cohort 1 was \$684,467 resulting in the award amounts below.

Identification of Cohort 2:

The college subsequently determined that students who enrolled in the summer term continued to face impact from the COVID-19 virus. Cohort 2 consisted of summer semester students who met all eligibility requirements as stated above.

Students attending the Spring term who did not complete the 2020-2021 FASFA prior to the disbursement to Cohort 1 were considered for Cohort 2 if they submitted a 2020-2021 FAFSA and met all eligibility requirements as stated above by April 1, 2021. Student Affairs contacted this group of students and offered assistance with filing a FASFA application by the stated deadline.

The total funding amount allocated to the Cohort 2 during the Summer term to 903 summer students and spring semester students who met all eligibility requirements by April 1, 2021 to was \$372,369.

The total funding amount allocated to Cohort 1 was \$372,369 resulting in the award amounts below.

The disbursement of Cohort 2 to student accounts took place during the first week of July.

Should any Emergency Grant funds remain following the distribution to Cohort 2, the college will disburse the balance of remaining funds to the eligible students identified in Cohort 1 and Cohort 2. Funds will be disbursed prior to the completion of the Summer term. The College sent an email and text once the funds were disbursed to student accounts.

The American Rescue Plan was signed into law (Pub. L. 117-2 (Mar. 11, 2021)) which provides additional funds for the Higher Education Emergency Relief Fund (“HEERF”) to assist public and private nonprofit colleges and universities in preparing for, preventing, and responding to the COVID-19 global pandemic. These funds are separate from those awarded under the [Coronavirus Aid, Relief and Economic Security \(CARES\) Act](#), and [Coronavirus Response and Relief Supplemental Appropriations Act \(CRRSAA\)](#).

Emergency Financial Aid for Students under ARP:

The U.S. Department of Education (“USDOE”) has allocated \$3,938,838 to North Georgia Technical College (“the college”) for these emergency financial aid grants to students. The college has signed and returned to the USDOE the Certification and Agreement and the assurance that the College intends to use no less than 50% of the funds allocated under Section 314 (a)(1) of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) for students. These funds are to be used to provide Emergency Financial Aid Grants to Students for expenses related to the disruption of campus operations due to the COVID-19 pandemic. Eligible expenses include food, housing, course materials, technology, health care, and childcare. Students who meet basic eligibility criteria for federal financial aid (Title IV) funding and who have been determined to have an exceptional need were considered for the HEERF III. Information from the Free Application for Federal Student Aid (FAFSA) were used to determine eligibility for Emergency Grant Funds.

- Active enrollment during the Summer 2021 or Fall 2021 or Spring 2022 semester(s) for a minimum of one (1) credit hour in a program that leads to a certificate, diploma, or degree.
- Have completed a FAFSA for the 2020-2021 aid year for Summer 2021 or a 2021-2022 aid year FAFSA for Fall 2021 and/or Spring 2022.
- International and DACA students are eligible
- Have met all requirements for admission

Student Not Eligible for Emergency Grant Funds:

Student populations determined as not eligible for Emergency Grant Funds as defined by the U.S. Department of Education:

- Dual Enrolled High School Students
- Joint Enrolled High School Students
- Transient students – these students may receive funds from home institution
- Adult Education (non-credit) Students

Proposed Process for Awarding and Disbursing Emergency funds to Students

Based on the eligibility requirements above, the college initially identified 903 students who met eligibility requirements to receive Emergency Grant Funds. The college disbursed funds to those students determined to be eligible. Funds were awarded by the Financial Aid Department and disbursed to student accounts. Each student account showed a credit balance. ARP funds can be used to cover tuition and fees balances, if the student gives prior authorization. The Business Office disbursed any credit balance to BankMobile for release to the student.

The College will disburse funds to three cohorts: Cohort 1 from the Summer 2021 term, Cohort 2 from the Fall 2021 term, and Cohort 3 from Spring 2022 term.

Identification of Cohort 1:

Cohort 1 consisted of those students who have already completed the Free Application for Federal Student Aid (FAFSA) for 2020-2021 and have met all eligibility requirements stated above. The college initially identified 903 students who were enrolled in Summer 2021 semester for Cohort 1.

The total funding amount allocated to Cohort 1 was \$1,309,700 resulting in the award amounts below. The College sent an email and text once the funds were disbursed to student accounts.

Identification of Cohort 2:

The college subsequently determined that students who enrolled in the Fall 2021 term continued to face impact from the COVID-19 virus. Cohort 2 consisted of Fall 2021 semester students who met all eligibility requirements as stated above. NGTC has identified 1,475 students who are enrolled in the Fall 2021 semester and eligible for Emergency Financial Aid Grant to students.

The total funding amount allocated to Cohort 2 was \$1,317,143.84

The disbursement of Cohort 2 to student accounts took place in October 2021. The College sent an email and text once the funds were disbursed to student accounts.

Identification of Cohort 3:

The college subsequently determined that students who will be enrolled in the Spring 2022 term will continue to face impact from the COVID-19 virus. Cohort 3 will consist of Spring 2022 semester students who met all eligibility requirements as stated above. NGTC has tentatively identified approximately 903 students who will be enrolled in the Spring 2021 semester and could be potentially eligible for Emergency Financial Aid Grant to students.

The disbursement of Cohort 3 to student accounts will take place in March 2022. The College will send an email and text once the funds were disbursed to student accounts.

The total funding amount allocated to Cohort 3 is \$1,311,539.16.

Should any Emergency Grant funds remain following the distribution to Cohort 3, the college will disburse the balance of remaining funds to the eligible students identified in Cohort 1, Cohort 2, and Cohort 3. Funds will be disbursed prior to the completion of the Spring 2022 term.
